WHO CAN GET A LEASE?

IBA provides tailored leasing solutions to grow Indigenous business. Any Indigenous organisation or business can apply. Consideration will also be given to organisations that deliver Indigenous programs.

WHAT CAN YOU LEASE?

Most plant, equipment, machinery or vehicles that you need for your business can be leased. Either new or used assets can be provided.

WHY BUY WHEN YOU CAN LEASE?

- Leasing conserves cash for other business needs.
- Options for ownership at the end of the lease.
- Competitive interest rates (between 4-7%) depending on your circumstances.
- Fixed payments for the term of the lease.

LEASING FEATURES

- IBA specialise in remote leasing - minimal end of lease penalties.
- Obligation free quote.
- Price matching where possible.
- Payments may be tax deductible.
- Flexibility of lease terms and end of lease options.
- Operating and finance leases available.

HOW LONG DOES IT TAKE TO GET THE ASSET?

Depending on the availability of the asset selected, the manufacture and delivery of the asset can take anywhere from 1 to 12 weeks from ordering. In order to collect your asset, IBA must have received a signed lease form, the first rental/settlement payment and a copy of the certificate of insurance, noting IBA as an interested party.

HOW DO I APPLY?

1. Contact IBA to arrange an obligation free quote.
2. If you agree to our quote, we will request financial information from you for a credit assessment. This may include financial data (balance sheet and profit and loss statements), company details, director identification and business plans.
3. If approved, you will be invited to apply. An application form will be provided to you and final lease details will be negotiated.
